Justice Riggs was appointed to the NC Supreme Court in 2023 by Governor Roy Cooper. Reives is known for his skills working across party lines and has sponsored legislation to strengthen public schools and to help protect children, the disabled, the environment, and property rights. He listens to the needs of the constituents and has championed specific legislation to help Chatham County meet its vision of tomorrow.

# Team Harris-Walz Turns Convention Momentum Into Action. North Carolina Given a Huge Platform in Chicago

The DNC provided yet another example of all eyes being on the Tar Heel state and the true belief across the country that we will flip North Carolina blue in November.

NC DNC Convention Highlights:

• Governor Cooper was given the primetime slot of introducing VP Harris before her historic acceptance speech. As Governor Cooper said, he gave "the closing argument" to the country on why Kamala will be a great President, providing examples of their time working together as state AGs.

- Durham Mayor Leo Williams also gave a speech on stage at the United Center to the delegates and the folks watching at home.
- North Carolina's delegation was placed right next to the stage and Chair Clayton's roll call speech went viral and had the entire arena energized.
- The DNC convention told the story of how Kamala Harris and Tim Walz are fighting for the people, for our freedoms, and for our future while Donald Trump is only fighting for himself.
- Now, Democrats are turning the historic energy that was on display throughout the convention into real action to reach voters in the states that will decide this election.
- Convention week was the biggest organizing week of the campaign, with volunteers signing up for nearly 200,000 new shifts.
- Team Harris-Walz raised \$82 million during the convention with one-third coming from first-time donors. And in just over a month since launch, Team Harris-Walz has raised \$540 million a record for any campaign in history.
- On Friday, Team Harris-Walz launched a new ad, "Opportunity," amplifying Vice President Harris' vision for an opportunity economy that was on display in Chicago.
- This week, Vice President Harris and Governor Walz will kick off a bus tour across Georgia to speak directly to voters in their communities and harness the energy surrounding the Harris-Walz ticket into volunteer power.
- Team Harris-Walz is ready to use the momentum from the historic week to send Vice President Harris and Governor Walz into the final stretch of the campaign, ready to win.

# NCDP Chair Anderson Clayton Statement on Republicans' Latest Efforts to Disenfranchise Voters, August 27, 2024

"These Republican lawsuits are the latest in a series of disingenuous attempts to sow doubts about the integrity of the election system, and to suppress voter turnout in the 2024 election. Despite being well aware of the procedures the State Board of Elections maintains to keep our elections secure, the Republican Party waited until just days before voting begins in North Carolina to file yet another frivolous lawsuit attempting to burden North Carolinians' right to vote. North Carolina Democrats will remain relentless in our efforts to ensure that every eligible voter has the information they need to access the ballot box during the 2024 voting period and beyond."

# NCDP Chair Anderson Clayton Press Conference on Justice Phil Berger Jr. Refusing to Recuse Himself from Critical Case Involving His Father, Phil Berger Sr.

On August 29, NCDP Chair Anderson Clayton held a press conference calling out North Carolina Supreme Court Justice Phil Berger Jr.'s refusal to recuse himself from two high-profile cases involving his father, Phil Berger Sr., the Republican Senate leader.

The court's Republican justices denied Governor Roy Cooper's motion requesting Phil Berger Jr.'s recusal on Friday paving the way for him to decide on giving Phil Berger Sr. more power in his position.

#### Siler City Among Local Governments Receiving Grant Funding for Park Projects

On Thursday, August 29th, Governor Cooper announced that the Parks and Recreation Authority would be awarding \$17.9 Million in grant funds to local communities for park projects across the state. Siler City was awarded \$500,000 and is one of 46 localities across North Carolina that is receiving this funding.

Funding for these projects came from the Parks and Recreation Trust Fund (PARTF) and the Accessible Parks Grant Program. A second round of funding for the Accessible Parks Grant will open in September. To read the full announcement, **click here!**

#### **Act Swiftly Against Ticket Scams**

We all enjoy going to live shows and games to see our favorite artists or sports teams, but unfortunately scammers prey on our excitement. One North Carolinian was scammed out of \$1,200 after thinking they were buying tickets to a **Taylor Swift concert**. Social media gives bad actors new ways to trick people. Sometimes scammers will spoof or hack the account of a real person, who is not involved. They use a real person's account on social media to appear legitimate and trustworthy and try to

sell you tickets, and people fall for it because they know or have shared connections with the person. There are also good old-fashioned scam postings across the internet, including in online ticket sales groups.

If you are trying to get tickets to an event, make sure you are taking the following precautions to prevent ticket sale scams.

- Buy tickets through reputable ticket sale sites and double-check the URL on the web browser by looking for a lock icon and making sure it starts with "https:".
- Look for and read the refund policy carefully. Reputable sellers should have this
  information clearly displayed, and they should be able to answer any questions
  you have about your tickets.
- Do your research to ensure that the ticket you want to purchase is comparable to prices from other sites. If the price seems too good to be true, it probably is.
- Use a credit card when buying tickets so you can dispute the charge.
- If tickets are being resold in person, remember that state law prohibits charging anything more than \$3 over the face value of the ticket.
- If you do decide to purchase a ticket secondhand from someone on a social media site, make sure you are sending your money through a secure channel and the names of the seller and social profile account match.
